



Terms and Conditions for Photography/Videography Services

1. Service Agreement

1.1. Services Provided: The photographer/videographer agrees to provide content creation services as specified in the project agreement, including photography, videography, editing, and post-production work.

1.2. Equipment and Props: The photographer/videographer will provide all necessary equipment unless otherwise specified. Any special props or equipment required by the client must be arranged in advance.

2. Financial Terms

2.1. Payment Terms: Payment schedule and methods will be outlined in the project agreement. A deposit will be required to secure your booking.

2.2. Additional Charges: Extras requested during production will be charged as add-on fees on top of the original agreed pricing.

3. Project Execution

3.1. Client Responsibilities: The client agrees to cooperate fully with the photographer/videographer, including providing necessary information, access to locations, and timely feedback on drafts.

3.2. Location and Permits: The client is responsible for securing any necessary permits for shooting locations and obtaining all necessary permissions and releases from individuals or third-party locations appearing in the production.

3.3. Delivery of Final Product: The timeframe for delivery of the final product will be specified in the project agreement. Digital files will be provided in the format agreed upon.

4. Editing and Revisions

4.1. Revision Policy: The agreed-upon price includes up to three (3) editing revisions of the project. Any additional revisions will be subject to additional charges.

4.2. Feedback Process: Feedback must be given by one nominated person from the client's business. Internal agreement on feedback is required before submission to the editor.

5. Legal Considerations

5.1. Copyright and Usage Rights: The photographer/videographer retains copyright of all images and footage. Usage rights are granted to the client as specified in the project agreement.

5.2. Liability: The photographer/videographer's liability is limited to the total amount paid for services. We are not responsible for consequential damages or weather-related impacts on production.

5.3. Indemnification: The client agrees to indemnify and hold harmless the videographer and crew from any claims arising from the production.

5.4. Confidentiality: Both parties agree to keep confidential any proprietary information shared during the project.

6. Project Changes and Cancellation

6.1. Amendments: Any changes to these terms and conditions or the project scope must be agreed upon in writing by both parties and may result in additional fees.

6.2. Cancellation Policy: Cancellations must be made in writing. Refunds depend on notice given and expenses incurred. The videographer may retain deposits and charge additional fees to cover incurred expenses.

7. Force Majeure

7.1. Neither party shall be liable for failure to perform due to circumstances beyond reasonable control, such as acts of God, war, or severe weather conditions.

8. Additional Provisions

8.1. Raw Footage: All RAW footage will be deleted after the completion and delivery of the project.

8.2. Promotional Use: The videographer retains the right to use footage and images captured during the production for promotional purposes.

8.3. Timely Delivery: The videographer will make every effort to ensure timely delivery but is not responsible for delays beyond their control.
